Please read carefully before you fill out the enclosed application.

APPLICATION

We need the application filled out completely. Be sure to give us any information that will make it easier to approve your application. If you fail to fill in all the information requested, it may result in a delay in your being approved. Please include a check for your membership dues along with your application, made out to Indianhead, as your application will not be considered without your enclosed check. You will need to pick the membership classification that most suits your particular situation. Please read through the membership section of this cover letter to make your choice.

APPLICATION PROCESS

Once your application has been received, it will be reviewed by the Indianhead Membership Chairman and then presented at the next Indianhead Board of Directors meeting. Once the Board approves your application, you will be notified by our Membership Chairman and will then be permitted to attend any meeting of the Indianhead. It is understood that we expect an Indianhead member to make every effort to attend our meetings on a regular basis. The Indianhead Board meets prior to all regular Indianhead meetings.

INDIANHEAD MEETINGS

Indianhead meets the second Monday of the following months:

Jan., Feb., April, May, June, Oct. & Nov.

Note: We may have to change some dates on occasion due to other conflicts with seminars, WPPA activities, etc.

DEFINITIONS OF MEMBERSHIP

ACTIVE Membership may be extended to owners, partners or managers of portrait or commercial studios, provided photography is their principle source of earned income. At least 50% of earned income must be from photography. Must be proposed by an Active, Husband & Wife, Life or Sustaining Member. Has one vote, may hold office, may enter prints in competition and be awarded ribbons. Limited to one Active Member per business.

ASSOCIATE Membership may be extended to the immediate family of an active member, or to persons employed by an active member provided photography is their principle source of income. At least 50% of earned income must be from photography. Must be proposed by an Active, Husband & Wife, Life or Sustaining Member. Same privileges of membership as an Active Member, except no vote.

HUSBAND & WIFE Membership may be extended to the husband & wife who own and both work at their studio provided that their main source of income is from photography. Must be proposed by an Active, Husband & Wife, Art-Tech, Life or Sustaining Member. Each has the same membership privileges of membership as an Active Member.

SUSTAINING Membership may be extended to a person whose major interests are the distribution photographic equipment or supplies or are members of a firm providing services to professional photographers. Sustaining members may attend meetings, be heard, but has no vote.

ASPIRING Membership may be extended to a person engaged in photography on a serious, yet limited, basis who aspires to qualify for active membership within a two year period. This membership is limited to two years, but may be extended for one additional year with board approval. An Aspiring member may attend regular meetings, be heard, but has no vote and may not hold any office. May enter print competition, but may not be awarded any ribbons. Must be proposed by an Active, Husband & Wife, Life or Sustaining Member.

NOTE: To apply for membership as an Active, Associate, Husband & Wife or Aspiring, you must currently be a member of the Professional Photographers of America or agree to apply for membership within 60 days of conditional acceptance for membership by Indianhead. Membership with PPofA must be maintained to remain a member of Indianhead.
